

Castle Chess, Inc. Release of Liability, Assumption of Risk, and Parental Consent Agreement

In consideration of being permitted to participate in the Castle Chess Camp, I the participant, and my parents, if I am under 18 years old, 1.) Agree that I understand the nature of the camp and that I am qualified, in good health, and adequate physical condition to participate in the camp. I further acknowledge that the camp will be conducted in outdoor and indoor locations where injuries can occur. 2.) I fully understand that although the main camp activity of chess is not dangerous, there will be free time and recreation while at camp that always involve risk. These risks may be caused by the actions or inactions of myself, or of others participating in the camp (including other campers, staff, or volunteers). There may be other risks not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the camp. 3.) I hereby release, discharge, and promise to hold harmless, now or in the future, Castle Chess, Inc., their respective administrators, directors, staff, volunteers, other participants, and Emory University ("Releasees") from all liability, claims, demands, losses, or damages on my account. I further agree that if, despite this release and waiver of liability and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will hold harmless each of the Releasees from any litigation, expenses, attorney fees, loss, liability, damage or cost which any of them may incur as the result of such a claim. 4.) I agree that I will, at all times during my participation in the camp, adhere to all safety rules and obey camp regulations. I agree to abide by the No Smoking/No Alcohol/No Drugs policy while at Castle Chess Camp. I understand that the consequences of violating this agreement or in any other way seriously jeopardizing the well being of our group will result in my being sent home immediately at my or my parent's expense. If I have any problems or knowledge of conditions that could seriously jeopardize the well being of our group I will feel free to inform the staff or otherwise seek their help. 5.) I further understand that my name and photograph may be used in promotion, advertising or documentary materials for Castle Chess, Inc. I consent to such uses and waive any rights of privacy, publicity or compensation regarding those uses. 6.) I have read this agreement, fully understand its terms, understand that I have given up certain rights by signing it and have signed it freely and without any inducement other than my opportunity to participate in the camp. I intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. I fully understand that if not of legal age, under 18 years old, that my parent(s) or legal guardian (s) have fully read the above Waiver and Release and understand it and that I am fully bound by their signature.
